The S.O.I.T.C. activity was established May of 2006, at the Elkhart Fair grounds in Goshen IN by owners of 60 DoubleTree RV units. The actions accomplished at the meeting and to present date are as follows:

- Approved Charter & By-Laws, elected a seven member Board, assigned dues and approved that the elected Board finalize any business processes that would aide the growth of the organization.
- Successfully Incorporated and registered the club as a non-profit activity with the Indiana Secretary of State office and publishes a quarterly news letter to its members.
- Received approval from the Internal Revenue Service as a approved federal exempt tax activity.
- Established and maintains a Club forum with general topics for any and all suites owners and also a members only section that communicates SOITC formal and informal business subjects. You can connect to the forum site from the link <http://www.suitesowners.com/>
- The Club has Liability Insurance for its members who attend scheduled RV gatherings, the Officers of the Board also have liability insurance coverage and the Treasures position is also bonded.
- Implemented a sponsorship program with business RV dealers and after market supplier participants, published a common informational recruiting brochure.
- Selected Rally sites for 2008, (Amana Colonies IA) 2009 (Elkhart FG, Goshen IN) and 2010 (Garden of the Gods, Colorado Springs, CO) which are under contract. We are researching for annual rally locations in our Eastern region for 2011 and Canada for 2012

Many owners have gathered together and formed State and or area chapters with scheduled outings and entertainment for all to enjoy.
